

INVITATION FOR FINANCIAL PROPOSALS

TPL-301-1125-OAB-002: BIDDING FOR THE SUPPLY AND DELIVERY OF LSGO THROUGH THE PIPELINE FOR DISTRIBUTION TO THE ZAMBIAN MARKET FOR FEBRUARY 2026.

BACKGROUND:

The Government of the Republic of Zambia, through the Ministry of Energy, opened up TAZAMA Pipeline to ERB Registered Oil Marketing Companies (OMCs) in Zambia for transportation of imported Low Sulphur Gas Oil from Dar-Es-Salaam, Tanzania to Ndola, Zambia for the Zambian Market under the Pipeline Open Access Guidelines.

TAZAMA Pipelines Limited now invites sealed Financial Proposals (bids) from Pre-qualified Oil Marketing Companies for the Supply and Delivery of One (1) Lot of Low Sulphur Gasoil Cargo Shipments through the Pipeline for **February 2026** as detailed below:

No altered submissions will be allowed. Any ALTERATIONS will result in Disqualification from the Bidding Process.

Please NOTE that Prequalified OMCs who owe TAZAMA Pipelines Limited Transport Differential and Pumping Fees at the time of invitation for Financial Proposals are not eligible to participate for this invitation for Financial Proposals.
